

# CHRISTIANITY DISCRIMINATES

Part of the campaign of brainwashing, to which the American public is being subjected, is a huge and well financed effort to make us believe that all discrimination is bad. Those of us whose memory reaches back 40 years or more, will recall the ability to discriminate between things of different value or utility, was then recognized as a most essential part of intelligence. Those too dull to see differences, where they exist, were considered stupid. How does it happen the subsidized press, radio and television commentators now so bitterly denounce all who can discriminate? They even try to make us believe discrimination is not Christian! Since all of the devil's doctrines are now being preached under the false pretense of Christianity, let us examine the only source from which we can determine Yahweh's position on the subject of discrimination.

From beginning to end, the Bible is a book of discrimination, discrimination by Yahweh and discrimination which Yahweh commanded us to make. We find the first record of Yahweh's discrimination in Genesis 4:3-5 where we read, "And in process of time it came to pass that Cain brought of the fruit of the ground an offering unto Yahweh. And Abel also brought of the firstlings of his flock and of the fat thereof. And Yahweh had respect unto Abel and to his offering: but unto Cain and to his offering He had not respect." What is this?

This is only the beginning. Genesis 5:3-4 describes Adam's family, yet it mentions by name only one of his children Seth, and barely notices the existence of the others. Discrimination? Yes, indeed! Right on down through verse 31, this chapter notes the existence of each succeeding generation, yet approves only one in each generation by giving his name. This brings us to Noah. In Genesis 6:17-18, we find that Yahweh discriminated in favor of Noah and his family and against all the other people living in that land. Yahweh saw a difference between them? Of course he saw a difference. But today we are told we must pretend there is no difference between the races, even when we clearly know this pretense is false.

Follow me on through Genesis and we find Yahweh discriminated in favor of one and against others in every generation down to Abraham. Among Abraham's children, Yahweh discriminated in favor of Isaac and against Ishmael. Among Isaac's children, Yahweh again favored Jacob over Esau, making Jacob the father of Yahweh's people and changing his name to Israel, while Esau and his descendants were cursed with Yahweh's indignation forever. Likewise, Yahweh favored Joseph over all his eleven brothers and again Yahweh discriminated in favor of the Israelites and against the Egyptians. How awful, say our modern liberals, why this is racism! Yes, frankly it is and

it is Yahweh's own choice at that. Yahweh has certainly lost the minority group vote, but I am grateful to Him for setting an example which we can follow.

Some people have been misled, by their churches, into the belief the Old Testament is only a record of Yahweh's mistakes and failures. They teach Yahweh had to abandon all this and make a new start in the New Testament, which changed everything. No greater falsehood was ever taught. Yahweh was right the first time and all the time. The Old Testament and the New Testament are perfectly consistent. There is as much Christianity in the Old Testament as there is in the New Testament. The New Testament is as much an Israel book as is the Old Testament.

No doubt many of you have heard many preachers say discrimination is not Christian. Let's look into this, who is the supreme authority on what is Christian? It cannot be anyone except Yahshua, no one can tell me Yahshua was unChristian.

Fortunately, Yahshua never used any of the weasel worded evasions which are considered polite today. He always fearlessly spoke the exact truth, in words too plain to be mistaken. All the gospels record that among the Jews, Yahshua spoke His teachings in parables which they could not understand. Later, He explained these parables to His disciples in private. At least three of the gospels record that Yahshua explained to His disciples why He took such pains to keep the Jews from understanding Him. In Mark 4:11-21 we read, "And he said unto them, Unto you it is given to know the mysteries of the kingdom of Yahweh: but unto them that are without, all these things are done in parables: That seeing, they may see and not perceive; and hearing, they may hear and not understand: Lest at any time they should be converted and their sins should be forgiven them." Now this is real discrimination! How could you make it any stronger?

This is not all. Both Matthew 15:22-28 and Mark 7:25-30 record that when a Canaanite woman asked Yahshua to drive the demon out of her daughter, He replied that it was not proper to take the children's bread and cast it to the dogs. Not until she acknowledged that the children of Yahweh, the true Israelites, must first receive His gifts, and through them the kingdom of Yahweh would be brought to the other races. Not until then did He consent to heal her daughter. Discrimination? Yes, indeed! Racism? Certainly! But who dares to call Yahshua unChristian? Yes, I think that some of the liberal and modernist preachers will actually say this! This only shows clearly how much Satanism is falsely masquerading as Christianity today.

This discrimination becomes even stronger. In Matthew 7:6 Yahshua warns all His followers, "Give not that which is holy unto the dogs, neither cast ye your pearls before swine, lest they trample them under their feet and turn again and rend you." Certainly everyone knows Yahshua was not so foolish as to think that His disciples were going into the barnyard and start preaching to the four legged animals there. When He spoke of dogs and swine, He was speaking of the two legged varieties. **Discrimination between the races? Certainly!!!** But we haven't had sense enough to believe Him and obey Him. We have given that which is holy, our Christian religion, unto the dogs in Africa and Asia. Today, those missionaries who did not escape in time have been eaten in Africa or are slowly dying in Red Chinese prisons. The precious pearls which Yahweh gave to us, the inventive skill He placed in our minds, the high

civilization which enables us to produce great abundance of every useful produce, these we have cast before the swine of the earth. They now trample under their feet the peaceful prosperity we tried to give them and use our science, our machines, even the surplus food we ship them, as weapons with which to destroy us.

Yes, I know how the minority groups and the mongrelizers are raging against what I am saying. But it is time that Yahweh's truth be told before it is too late. Yahshua warned us to discriminate between races, just as He discriminated. In His last talk with His disciples recorded in John chapters 14-17, Yahshua said that He would send to them the Holy Spirit, the Spirit of truth, whom the nations of the world order (cosmos) cannot receive because they do not see Him nor know Him. Yahshua said that He prayed only for those who were His and not for the world system.

Yahshua knew the folly and falsehood of pretending that all people, all races, are alike or equal. He knew that every sacrifice of truth on the polluted altar of expediency and politics brings its terrible penalty in national and racial degradation, which only their destruction has ever succeeded in cleansing.

All history is a vast junkyard of the wreckage of empires which ignored this lesson and in consequence thereof, perished. Several times in our past history, we were on this path to destruction and were only saved by the direct intervention of Yahweh. Today, we have allowed corrupt leaders to take us so far into this shadow of death that again, only the promised intervention of Yahweh can now save us.

We have His promise to save us if we will get down on our knees and beg for forgiveness and then He will heal our land. If we will do our part Yahweh will keep His promises to Israel. While we still can, let us turn back to the word of our God, Yahweh. Discriminate between that which is good for us and that which is deadly. That which is our own and that which is alien to ourselves and to Yahweh.

**Critical note** by Clifton A. This is not at all the reason why Yahshua healed the Canaanite woman's daughter. In a brochure I wrote entitled *Why Did Christ Heal The Daughter Of The Canaanite Woman?*, I went into greater detail on this subject of which I will take excerpts here: "**CHRIST HAD NO CHOICE IN THE MATTER:** If one will simply take the time to study these things rather than just be a surface reader, the entire incident will become clear. ... **THE OVERALL PICTURE:** Without exploring the entire context of this subject it eludes us, as often, we too quickly jump to conclusions. Therefore, let's go back to the beginning and progressively bring it up to Yahshua-Christ's time. To start this progression, let's go back to Genesis 15:18-21:

**"18 In the same day Yahweh made a covenant with Abram, saying, Unto thy seed have I given this land, from the river of Egypt unto the great river, the river Euphrates: 19 The Kenites, and the Kenizzites, and the Kadmonites, 20 And the Hittites, and the Perizzites, and the Rephaims, 21 And the Amorites, and the Canaanites, and the Girgashites, and the Jebusites."**

The Canaanite woman whose daughter Christ healed was of one of these ten tribes or a mixture of several of them. Here at Genesis 15:19-21 are listed ten nations and they eventually race-mixed so much that in Deuteronomy 7:1-2 there are but seven. The Kenites, Kenizzites and Rephaims were completely absorbed by the other nations of this group from which the bad-fig “Jews” are in part descended.

Later at Numbers 33:55 it says: “**But if ye will not drive out the inhabitants of the land from before you; then it shall come to pass, that those which ye let remain of them *shall be pricks in your eyes, and thorns in your sides, and shall vex you in the land wherein ye dwell.***”

It is overwhelmingly obvious from this Scripture that Yahweh gave Israel a commission to kill every last Canaanite, man, woman and child. Secondly, it is crystal-clear that because the twelve tribes didn’t obey Yahweh’s decree that He decided to use the Canaanites to chastise Israel, as is evident at Hebrews 12:8: “**But if ye be without chastisement, whereof all are partakers, then are ye bastards, and not sons.**”

You see, the Canaanite woman whose daughter Yahshua-Christ healed had Him over the proverbial barrel, or “on the spot” one might say. Except on condition that one has only a 2x4 mentality ..., otherwise, one can readily comprehend that the Canaanites were given a temporary reprieve, or as we might say a “stay-of-execution.” So the only reason that makes any sense as regards to Christ healing the daughter of the Canaanite woman was so that daughter could procreate more Canaanites to be “pricks” and “thorns” to Israel! In fact, Yahshua-Christ had just previously given the parable of the “wheat and tares”, projecting their demise in the end-time “harvest”, so Christ could hardly default against His own spoken Words, could He? Therefore, He had no choice in the matter of healing the Canaanite woman’s daughter! ...”
